

## The big "WHY"

- TVIs who serve infants and toddlers need more information than school-based teachers...
- Different settings, service delivery process, and role
  - Home visiting
  - Bioecological and Family Systems Theory
  - Child development is strongly influenced by the connections in their microsystem/family (Bronfenbrenner, 1979).
  - State's Part C system

Part C early intervention builds upon and provides supports and resources to <u>assist family members</u> and caregivers to enhance children's learning and development through everyday learning opportunities.

## The 5 Pillars of Early Intervention

- 1. Family Centered Practices
  - 2. Natural Environments
    - 3. Children's Learning
      - 4. Adult Learning
      - 5. Quality Teaming

## Family Centered Practices

Early intervention is NOT meant to happen "to" a family but "with" a family.

- Collaborative
- Strength based
- Family Choice and Control

(Hatton et al., 2018 - DVIDB position paper)

## The Paradigm Shift

#### Part C (Birth to 3 at home)

- Parent priority and concerns
- Activity or routine based
- Learning occurs between specialist's visits
- IFSP
- Natural environment
- Coaching to parents (indirect to child)

#### Part B (3-21 in school)

- Educator's priority
- Skill based
- Learning occurs during instruction
- IEP
- Least Restrictive Environment
- Direct instruction



## Coaching...best practice in El (Rush & Shelden, 2019)

#### **Direct Teaching**

- Teacher develops, guides, and monitors the learning objectives based on assessment. (i.e. "I do, we do, you do")
- Parent is not included in instruction as it is teacher led and directed at child only.
   "Medical model of El"

#### Consultation

- Consultant gathers information to identify and analyze the problem, then makes recommendations to resolve
- Parent is passive participant and expected to follow directions made by specialist.

#### Coaching

- Coach works to build capacity of parent through 2- way joint planning, observation/modeling, reflective discussions, action orientated feedback
- Parent is an active participant and owns the solutions (goals and plan).





## 5 Key Components of Coaching

- 1. Joint planning
- 2. Observation
- 3. Action/practice
- 4. Reflection
- 5. Feedback

## THE MATRIX APPROACH

In Three Phases

- Planning
- Engagement
- Reflection





## **Planning**

- Outcomes
  - Ask the parent
  - Identify
  - Write it down
- Routines
  - Ask the parent
  - Identify
  - Write it down

- Problem-solving activities
  - Define problem
  - Define one-week goal
  - Problem-solve solutions
- Choose activity
- Set up the environment



## Engagement

- Observe first
- Coach second
  - Affirm parent competence
    - "What a great idea! I think he is responding so well because of the way you are..."
  - Focus attention and provide developmental information
    - "Did you notice how he smiled and leaned forward? He also looked after the object when it fell. That shows he has object permanence! He understands it doesn't disappear. Some next steps might be..."
  - Provides suggestions and modeling
    - "You might want to encourage him to search for the dropped toy by..."
    - "I wonder what would happen if you would..."

Based on the Triadic Strategies as described by McCullum and Yates

### Reflection

- Come back to matrix
- Write changes or additions to planning notes.
- Extend
  - Who might you teach?
  - What other materials?
  - What different times of day?

(Writing it down promotes follow-through)
