

Agencies Receiving Federal Quota Funds Due Under an Act to Promote the Education of the Blind, Fiscal Year 2023

The Federal Quota Program was initiated in 1879 by the Federal Act to Promote the Education of the Blind. This program is a means whereby a per capita amount of money is designated for the purchase of educational materials for each eligible student registered through an established Federal Quota account. These Federal Quota accounts are maintained and administered by the American Printing House for the Blind (APH) and its Ex Officio Trustees.

The Federal Quota Registration is the census that records students who are eligible to receive materials provided by the Federal Act to Promote the Education of the Blind. The specific purpose of the annual Federal Quota Census is to register students in the United States and Outlying Areas who meet or function at the definition of blindness and are therefore eligible for adapted educational materials from APH through the Act to Promote the Education of the Blind.
